



# OPEN ACCESS FOR GERMANY

ADVANCING  
**DISCOVERY**

More than 900 German institutions are eligible to participate in the agreement between Springer Nature and Projekt DEAL, meaning that corresponding authors\* affiliated with these institutions are eligible to publish their articles open access without being invoiced by Springer Nature. The agreement includes more than 2,000 hybrid journals across the Springer Nature portfolio (from January 2020) and more than 500 fully OA journals (from August 2020).

If you are a corresponding author\* affiliated with a German university or research institution, you are entitled to publish open access in our journals with fees covered by the German DEAL agreement.

## What authors need to know:

- You must be the corresponding author\* of the article.
- Article types eligible under this agreement are: Original Paper, Review Paper, Brief Communication, Editorial Notes+, Book Reviews+, Letters+ and Reports+.
- Your article(s) accepted for publication in Springer Open Choice (hybrid) journals must have a publication date of **1 January 2020** or later in order to be covered by the agreement. Your article(s) accepted for publication in BMC, SpringerOpen and Nature open access journals must have a publication date of **1 August 2020** or later in order to be covered by the agreement.
- You must be affiliated with an eligible institution.
- You must explicitly state your primary affiliation in the published manuscript, which is the institution at which the bulk of the research for the article was conducted.
- You must identify yourself during the author identification process (you will be asked to do this once your article has been accepted for publication). The institution selected during this process should be your primary affiliation, as this institution will be asked to verify eligibility and will be billed if the article is approved.

\* Acting as main contact for Springer Nature correspondence after editorial acceptance.

+ Hybrid journals only. Non-research articles in fully open access journals will not be covered by this agreement.

## Next steps:

- Once your article has been accepted for publication, you will be asked to confirm your institutional affiliation. To ensure rapid publication of your article, it is important to confirm your affiliation as soon as possible.
- Once you have confirmed your affiliation, Springer Nature and your institution will confirm your article's eligibility and you will be notified when your article has been approved.

## Who is the corresponding author?

The corresponding author is defined as the person who handles the manuscript and correspondence during the publication process. The corresponding author has the authority to act on behalf of all co-authors in all matters pertaining to publication of the manuscript, including supplementary material.

## There are 3 ways that we can recognise your eligibility for coverage under the agreement:

1. Selected institution	2. Institutional email	3. Location
This is the easiest way to be recognised. Please input your institutional affiliation (in English) when prompted. If you are affiliated with more than one participating institution, you must indicate a single affiliation when your manuscript is accepted, for cost-allocation purposes. You can still have multiple affiliations listed in your published article.	If you use your institutional email address, you will be automatically recognised as eligible to publish open access under your institution's agreement.	If you submit from within your institution's IP range, you will be recognised as eligible based on your location. It is always best to submit from your institution's network.

If you have been recognised as eligible in any of the ways above, your affiliation will be confirmed by your institution and you will be notified via email.
